A re-mutation to mottled agouti (a^m) occurred in the C3H chromosome of a (C3H/HeJ X C57B/6) F1 male. The mutation generally produces a mottled coat in both the heterozygote and homozygote but it can range in color from almost extreme non-agouti with little ticking to full agouti with no mottling.
