Immunologically privileged sites express Fas ligand (FasL), which protects them from attack by activated T cells that express Fas and die upon contact with FasL. These transgenic mice express Fas ligand under the control of a rat insulin promoter, which is active in beta cells of the pancreas. They exhibit heightened sensitivity to diabetogenic T cells, which is due to self-destruction of beta cells upon T cell-mediated induction of Fas.

Animals are typically ready to ship in 11-14 weeks. If a second recovery is required to produce the minimum number of animals, then delivery time would increase to approximately 25 weeks. If we fail to produce animals of the correct genotype, you will not be charged. We cannot guarantee the reproductive success of mice shipped to your facility. If the mice are lost after the first three days (post-arrival) or do not produce progeny at your facility, a new order and fee will be necessary.
