Detailed Description

Although *Ifngr2* deficient mice on the NOD/Lt background are defective in *Ifng* induced gene expression, they exhibit no significant difference in leukocyte subset (CD4 positive T cells, CD8 positive T cells, B cells, macrophages, dendritic cells, and granulocytes) as compared to NOD/Lt controls. Upon stimulation of cultured T cells *in vitro* with anti-CD3, *Ifngr2* deficient NOD mice produce more IFNG and significantly more IL4 than NOD controls. *Ifngr2* mutant mice develop IDDM at a similar rate as NOD/Lt controls (85% female incidence after 30 weeks in mutant mice versus 100% female incidence in standard NOD/Lt controls).
