Mice homozygous for this null allele (miR-17~92^{delta}) die perinatally, displaying cardiac defects and hypoplastic lungs. In fetal liver reconstitution experiments, a defect in B-cell development (partial block at the pro-B to pre-B transition) is observed. This strain may be useful in studying the link between the region's oncogenic properties and its functions during B cell lymphopoiesis and lung development.
