### Details

#### Detailed Description

*Lang-DTREGFP* mutant mice contain an internal ribosome entry site (IRES), a human diphtheria toxin receptor (DTR), and an enhanced green fluorescent protein (EGFP) downstream of the internal stop codon of the CD207 antigen (*Cd207* or Langerin) gene. Homozygotes are viable, fertile, and normal in size. Langerin is a transmembrane receptor produced by specialized antigen-presenting cells located in the skin called Langerhans cells (LCs), and other dendritic cells including dermal DCs and splenic CD8<sup>+</sup> DCs. Langerin is specifically localized in the Birbeck granules, where it is necessary for their formation. In these mice, DTR-EGFP expression is evident in the membranes of Langerin-derived DCs and CD8<sup>+</sup> DCs. Diphtheria toxin (DT) administration results in ablation of LCs for 4-5 days and LCs for 2-3 weeks, with no apparent affect on langerin<sup>-</sup> CD11c<sup>-</sup> DCs. These mice may be useful for visualizing and specifically eliminating Langerhans cells.
