Detailed Description

Integrins like *Itgb2* (integrin beta 2) are involved with processes of cell adhesion and cell surface-mediated signaling. Mutations in this gene have been associated with leukocyte adhesion deficiency type I (LAD1).

These mice express monomeric cyan fluorescent protein (mCFP) that has been knocked into/fused with the mouse *Itgb2* gene. Homozygotes are viable, fertile, show no overt abnormal phenotype, and express normal levels of ITGB2. ITGB2 expression can be visualized directly by live animal imaging without antibody injection or fluorescent cell transfer. All leukocytes expressing ITGB2 express mCFP for purposes of *in vivo* and *ex vivo* imaging. These mice are a versatile tool for studying leukocyte behavior as it relates to *Itgb2*.
