### Details

#### Detailed Description

The *Uts2r* gene encodes for a G-protein coupled receptor for urotensin II. These mice carry a knock out mutation of the *Uts2r* gene in which the single coding exon is replaced by a PGK-NEO cassette. Mice that are homozygous for the targeted mutation are viable and fertile. Aortas isolated from homozygotes do not constrict when treated with human urotensin-II. On a high fat diet, homozygotes display decreased liver mass and hepatic steatosis, increased weight gain, and elevated serum triglyceride and LDL & HDL cholesterol content levels, when compared to wildtype controls.

When crossed to mice carrying a knock out mutation for the *Apoe* gene (see Stock No. [002052](#)), the resulting double mutant mice exhibit more severe atherosclerosis, hyperlipidemia, and hyperinsulinemia, when compared to the *Apoe* knock out mice.
