### Details

#### Detailed Description

This bacTRAP line incorporates an EGFP-L10a ribosomal fusion protein targeted to the translational start site of the *Grp* (gastrin releasing peptide) gene. The fusion protein enables affinity purification of CNS cell-specific polysomal RNAs which can be used for gene expression profiling.

Expression was carefully assayed by immunohistochemistry (IHC) with an antibody against enhanced green fluorescent protein

(EGFP). The cerebellum, spinal cord, basal forebrain and corpus striatum, brainstem, and cerebral cortex were surveyed. Primary labeling was found to occur in unipolar brush cells of the cerebellum (mGluR1 subtype). Minor labeling of cerebellar Bergman glia is also seen. Fluorescence can also be visualized directly.
