Il17rc^{fl/fl} mice possess *loxP* sites flanking exons 2-3 of the interleukin 17 receptor C (*Il17rc*) gene. IL-17RC is a protein with high affinity for the receptor of proinflammatory cytokine IL-17. IL-17RC is expressed in nonhemopoietic tissues, and binds both IL-17A and IL-17F which are involved in the progression of inflammatory and autoimmune diseases. It can also form a heterodimer with IL-17RC, which together plays a critical role in host defense against extracellular bacterial and fungal pathogens. Mice that are homozygous for this allele are viable and fertile. When bred to mice that express tissue-specific Cre recombinase, resulting offspring will have exons 2-3 deleted in the *cre*-expressing tissues.

When bred to mice expressing Cre Recombinase in epithelial cells of the small and large intestines, resulting IL-17RC deficient mice lack IL-17A and IL-17F signaling and a reduction in H₂O₂ concentrations in the terminal ileum.
