Detailed Description

Upregulation of *Il11* expression is the dominant transcriptional response to TGF β 1 (TGFB1, transforming growth factor, beta 1) exposure in fibroblasts associated with fibrotic cardiovascular disease. *Il11* may provide a viable therapeutic target with fewer side effects than direct inhibition of TGFB1, a gene with pleiotropic roles.

In this targeted mutant strain, Cre-mediated excision of a loxP-flanked STOP cassette enables conditional expression of mouse *Il11* from a CAG promoter within the *Gt(ROSA)26Sor* gene.

Expression of *Il11* can be directed to fibroblasts through crosses with Tg(Col1a2-cre/ERT,-ALPP)7Cpd (see Stock No. [029567](#) or [029235](#)) and tamoxifen-induced expression of cre recombinase.
