**NOTICE TO RECIPIENT OF STRAIN(S) Including progeny and derivatives, "MICE".**

ACADEMIC AND NON-PROFIT entities may use MICE solely for internal, non-commercial research use and not for Commercial Purposes. Commercial Purposes means: uses of the Mice by any organization, including Recipient to perform contract research, screen compound libraries, produce or manufacture products for general sale, or to conduct research activities that result in sale, lease, licenses or transfer of the MICE to a for-profit organization.
