Each Recipient of MICE from JACKSON agrees that MICE and any by-products derived from the MICE shall be used by Recipient solely for internal research and shall not be sold or transferred or provided to any third party. Each Recipient further agrees not to use any agent or other third party to provide breeding or other services with respect to the MICE without the prior written agreement of JACKSON. Acceptance of the MICE from JACKSON shall be deemed agreement to these terms. The original source of the MICE is the INSTITUTION and were provided by The University of California San Francisco (UCSF).
