Commercial Purpose means: uses of the MICE by any organization, including Recipient to perform contract research, screen compound libraries, produce or manufacture products for general sale, or to conduct research activities that result in sale, lease, licenses or transfer of the MICE to a for-profit organization. However, industrially sponsored academic research shall not be considered a use of the MICE for Commercial Purposes per se, unless any of the above conditions of this definition are met.

As a service to the biomedical research community, The Jackson Laboratory ("JACKSON") provides these mice to Recipient solely for research purposes. Recipient agrees that the MICE and their descendants, if any, will not be bred for sale nor distributed to any third parties outside the recipient's institution, and will be used solely for non-commercial research purposes. For the avoidance of doubt, non-commercial purposes excludes the sale, lease, license, or other transfer of the MICE to perform contract research, to screen compound libraries, to produce or manufacture products for general sale, or to conduct research activities that result in any sale, lease, license. The original source of the MICE is the INSTITUTION. The MICE were created in a Howard Hughes Medical Institute ("HHMI") laboratory at INSTITUTION.
